## Meet Nannie Helen Burroughs

As we reflect on African American History Month and Women's History Month, allow me to introduce you to someone who positions herself in both camps. Nannie Helen Burroughs (1879-1961) was an exemplary student who graduated, with honors, from M Street High School (now known as Paul Laurence Dunbar High School) in Washington DC. Her strong academic accomplishments did not translate into meaningful employment. Undeterred, she made the decision to start her own school to educate and train African American women. Relying on small donations from Black women and children from the community, Burroughs managed to raise enough money to open the National Training School for Women
 and Girls.
She was active in the Woman's Convention of the National Baptist Convention. With many members who were fellow
 suffragists, the meetings provided a setting for discussions on suffrage topics. She believed suffrage for African American women was crucial to protect their interests in an often-discriminatory society.

Nannie Helen Burroughs served as President of the National Training School for Women and Girls from 1909 until her death in 1961. In 1964 the school was renamed in her honor. The Trades Hall is a National Historic Landmark.
Of note to Daytonians, an NCR cash register made in 1904 and marked with her name, was used for teaching students at the school.

LWV Greater Dayton Area honored a community organizer, an entire group of health care heroes, and a champion for developmentally disabled citizens (posthumously), at its 11th annual Dangerous Dames of Dayton fundraising event March 23rd.
The keynote speaker was Jana Collier, Publisher of Cox First Media and the Dayton Daily News, which recently accepted state-level accolades for groundbreaking political reporting during one historic year in journalism.
Participants joined the festivities virtually, yet gathered in one spirit toward honoring women and men in our community who leaped over barriers and fought against the odds to make our community a better place to live, just as our suffragist sisters did over 100 years ago.

Studied at Central State University \& Wilberforce University, and credits these institutions with cultivating the skills that contribute to her professional development in leadership, education, activism, empowerment, and service. Through her role as Executive Director of Dayton Young Black Professionals, she works to create a network that is a safe haven for young, African American career men and women to unite, network, cultivate their resources and thrive together. She is committed to a life of service and philanthropy for minority groups and marginalized people everywhere.

All our local Health Care Nurses continue every day to work fearlessly and tirelessly during this long and challenging pandemic to heal those impacted by COVID-19. They truly are heroes who every day put their lives on the line to help others. Sharon Hawkins, President of District Ten of the Ohio Nurses Association, accepts this award on behalf of all the nurses of the Dayton Area.

For over three decades, Brenda Whitney advocated for the dignity of the mentally challenged in our area. She changed zoning laws and "sweet-talked" Dayton area residents into "allowing" homes for challenged people in THEIR neighborhoods. She was a leader in the closing of state institutions and the reintegration of people with developmental disabilities into their communities. Brenda championed our forgotten people. Judy Leasure, colleague and life-long friend of Brenda, accepted the award in Brenda's memory.

# Program Planning Committee Ranks Issues for 2021-22 Focus 

The LWVGDA Program Planning Committee met virtually in January to recommend and discuss issues/ topics for consideration during the 2021-22 program year. Then participants recently ranked the issues using an on-line survey format (see ranked program topics below).
At the March Executive Board meeting, Vice President of Programming David Bodary thanked participants of the planning committee, and remarked that despite the inability to meet in person and debate the value of each issue in person, virtual meetings still resulted in robust and meaningful discussion thanks to the dedication of League members.
The ranked program topics and resulting report have been forwarded to LWV Ohio for consolidation with other regional Leagues toward development of a statewide programming focus.
Greater Dayton League members should be proud that information and resources provided by our planning committee to LWV Ohio on the subject of police reform are being used to lead the formation of a statewide policy highlighting police diversity training, crisis training, applicant screening and funding reallocation to mental health and anti-racism resources. ## NEW DIVERSITY, EQUITY AND INCLUSION (DEI) COMMITTEE ALREADY MAKING AN IMPACT

Members of the Diversity, Equity and Inclusion Committee, with Dona Fletcher serving as Chair, met with the CEO of the Miami Valley Regional Planning Commission and his Equity Manager to discuss ways we could access some of the data mapping they have done based on the 2020 election. Jo Lovelace
 Hill will work with their Geographic Information Systems (GIS) Project Manager to create maps that identify where voter participation gaps exists in the greater Dayton area. Diversity within the League was also discussed. Committee members feel that one of the barriers to more diverse League membership is a lack of financial resources among some potential members. The Ohio League is working on a flexible membership possibility, but it has not been adopted as yet. Dona Fletcher was told by the LWVO liaisons for DEI that they are working on a train-the-trainer workshop and a handbook. Our committee would like to do a workshop with the entire Board in July, details to be arranged.
