Last month, Naturalization Ceremonies resumed, and throughout April, after years of preparation, nearly 300 new citizens, took their Oath of Allegiance. As I started helping folks get registered to vote, and chatted with them about their journey, I gained an even deeper appreciation of what a privilege it is to live in the United States. I also had the opportunity to participate in a community mapmaking session. As we prepare for the upcoming redistricting process, our League is once again taking the lead to ensure that the process is fair, and that citizens' voices are heard. I got to join a group of League members led by Kim Senft-Paras, Lucy Anne McKosky, Laurel Kerr and Matt Krug, who gathered to practice before the Redistricting Committee, takes its "act on the road." During the session, everyone got the chance to discuss what boundaries define their community,



shared what they believe makes their community great, as well as the challenges it is facing. Honor survivors of gun violence on National Gun Violence Awareness Day



WEAR ORANGE JUNE 4

Join **Dayton Moms Demand Action** for their Wear Orange Weekend Event as they walk for survivors of gun violence and support the FUDGE Foundation. The FUDGE Foundation was started by Dion Green, a Dayton mass-shooting survivor, in honor of his father, Derrick Fudge.

HOW: Ask some friends to join you (stay COVID safe!) or walk alone. Optionally, you can ask for sponsors for your walk, donate to the FUDGE Foundation yourself, or both (bit.ly/

WHERE: It's your choice: Walk around the block, on your favorite path, or to your favorite hang out. Just walk!

WHEN: Anytime the weekend of **Wear Orange**, June 4-6.

WHY WEAR ORANGE ON NATIONAL GUN VIOLENCE AWARENESS DAY?

The **WearOrange.org** site explains that orange is the color that Hadiya Pendleton's friends wore in her honor when she was shot and killed in Chicago at the age of 15 — just one week after performing at President Obama's 2nd inaugural parade in 2013. After her death, they asked us to stand up, speak out, and Wear Orange to raise awareness about gun violence.

Since then, orange has been the defining color of the gun violence prevention movement. New York gun violence prevention advocate Erica Ford spearheaded orange as the color of peace through her work with her organization, Life Camp, Inc. Whether it's worn by students in Montana, activists in New York, or Hadiya's loved ones in Chicago, the color orange honors the more than 100 lives cut short and the hundreds more wounded by gun violence **everyday**.

The movement gains momentum when gun sense activists come together to fight for a future free from gun violence. Wear Orange originated on June 2, 2015—what would have been Hadiya's 18th birthday. Now, it is observed nationally on the first Friday in June and the following weekend each year. This year, National Gun Violence Awareness Day will be June 4, 2021.

On April 27, we gathered together in a Zoom Retirement Party for Susan Hesselgesser as we honored her dedication and contributions to our League of Women Voters since 2009.

We began our trip down memory lane with a look back to 2009, when Janis James was President and Susan was our part -time Education Director. Janis related how the Board recognized the need for an Executive Director to cover much more than our educational needs: it was necessary to hire someone to help manage the myriad of details that were previously all covered by volunteers, since so many League leaders now had full-time jobs.

Susan applied for that position and was immediately hired as our very first Executive Director under Jo Columbro's Presidency 2011-2013; Vivienne Himmell reminisced about Sue and Jo's time together serving our League.

Next Dona Fletcher talked about life with Susan from 2013-2015; since Patty Skilken was unable to attend the Zoom in person, Pat Bradley-Falke related Patty's memories from 2015-2017; Susan Byerly spoke about working with Susan in 2017-2019; and since Andy unfortunately was unable to attend in person, Penny Wolff finalized the Presidential Memories section of the evening by delivering Andy's heartfelt recollections of Susan from 2019-2021.

Republicans and Democrats move farther apart in views of voting access

The Pew Research Center presented a comprehensive look at various aspects of election rules and procedures at state and federal levels. Partisan divisions have grown exponentially as legislatures across the nation have introduced election law changes primarily attributed to debunked accusations of voter fraud. Findings from a national survey conducted from April 5-11, 2021, cover many of the contentious issues presently being examined by the League of Women Voters.

On March 3rd, 2021, the House of Representatives passed HR1, or the *For the People Act*. Now the bill has come to the Senate as S1. The *For the People Act* is a bill in the United States Congress to expand voting rights, change campaign finance laws to reduce the influence of money in politics, limit partisan gerrymandering, and create new ethics rules for federal officeholders.

LWVUS has issued talking points that will allow all Leagues to speak with one voice as we work to educate the public pertaining to this important piece of legislation:

The following should also be noted in determining how best to proceed:

"While we (LWVUS) do support the legislation, we recognize that it is not a perfect bill. There are pieces of it that the League will not promote or work to advance. State and local Leagues who are interested in supporting the *For the People Act* publicly should focus on (the League's talking points)."

Why we need a comprehensive package of democracy reforms:



- It should be easier, not harder, to vote.
 The For the People Act improves access to voting with reforms like Same Day Registration and Automatic Voter Registration.
- More needs to be done to protect voters' voices. The For the People Act requires independent redistricting commissions, ends voter roll purges based on failure to vote, and restores the Voting Rights Act.
- Our government should respond to the will of the people, not the interests of powerful corporations and wealthy donors.
- The For the People Act includes strong provisions for improving transparency in campaign finance and strengthening government ethics enforcement.

Members Voted to Merge Funding Accounts at LWVGDA 59th Annual Meeting

The 59th Annual Meeting of the LWVGDA took place on Tuesday, May 18, 2021 with 53 members attending via Zoom.

League President Andy Cobb welcomed the group and introduced League member Michelle Maciorowski, of MMM LC and Jon Scandling of Frantz Ward LLP (Cleveland), members of the Ohio Bar Association, who provided a program about the First Amendment and how it relates to the penalties for peaceful protests and civil disobedience at pipeline and other critical infrastructure sites proposed in SB 33.

During the meeting, Membership adopted a resolution to merge the 501(c)(4) (General Fund) and 501(c)(3) (Education Fund) into one entity. Beginning on July 1, 2021, LWVGDA will operate solely as a 501(c)(3) nonprofit organization with all donations now tax deductible. This change came after careful discussion among the Board with legal advice at each step and support from our state and national Leagues. By merging the two funds, developing the annual budget, as well as bookkeeping will be streamlined. Membership also voted to accept revised Bylaws for the new entity.

Mario recognized Andy Cobb, outgoing President, for her outstanding contributions to the League. Under Andy's leadership we engaged during a momentous presidential election, came out of a pandemic in good shape and finalized the merger of our two League entities, ensuring that we will move forward as a cohesive financial organization. Winifred Frazier and Paul Lamberger were recognized for 25 years of League membership.

We honored the memory of League members Lillian Sagstetter, Helen Watkins, Betsy Retterbush, Esther Wright, Brenda Whitney, Shirley Omietanski, Sarah Deets, Joyce Young, Ronald Katsuyama, Nancy Fisher and Murray Chapple with a moment of silence and offer our deepest condolences to their families.

The slate of officers was approved as presented: President, Mario; President Elect, Beth Schaeffer; Program VP, David Bodary; Voter Service VP, Jo Lovelace Hill; Webmaster, Rita Peterson; Funding and Development Director, Linda Fish; and Greene County Rep, Sandra McHugh. Rebecca Morgan, Pat Bradley-Falke, and Wendy Dyer were also approved as presented for the nominating committee.

Dick Hattershire, Treasurer, reported that despite the pandemic, the League's finances are in good shape. While income declined, expenses were lower. Membership voted to recommend the proposed Education Fund budget to the Education Fund Trustees for approval and to accept the General Fund budget, presented by Janine Kinnison, Chair of the Finance Committee. The budgets will be combined, effective July 1, 2021, when the merger of the Funds is completed. Neither projected income nor expenses will change after the merger.

Membership also voted to accept Recommended Programs, presented by David Bodary, Program VP. These include Social Justice: voter registration, suppression concerns, voter literacy; Government: redistricting, gerrymandering, fair elections, and election reform; and Environment: climate change, water safety, and environmental justice issues. The programs will be provided via our program on DATV, *LWV Empowering You*, webinars and hopefully, in-person presentations.

Tonya Wilson-Wood, representing the Diversity Equity and Inclusion (DEI) committee, updated Membership about their important work. The committee is currently planning a diversity training program for Board members and Staff, which will take place in July. The opportunity for diversity training for the membership at large is to be determined.

Chris Corba, Executive Director, gave an overview of highlights of the year, which were graciously penned by Susan Hesselgesser. Andy Cobb shared during her remarks, that she enjoyed her time as President, and looks forward to continuing her work with the League as a member. Mario, incoming President, thanked Andy again for her dedication to the League and the meeting was adjourned.
