Back in June, we received an invitation to submit a grant for National Voter Registration Day. In the past, they awarded mini grants to help with costs associated with the annual event which, this year, will take place on September 28. As I looked over the requirements, I noticed that they were only awarding eight to twelve grants, starting at \$5000, and were focusing on large metropolitan areas with significant races.



We were awarded one of eight grants from a pool of nearly 100 applications from across the country! What does that mean? That the League of Women Voters of the Greater Dayton Area ROCKS! The depth and multitude of programs and services this League has produced over the years and the dedication of its members have resulted in our "emerging as a top applicant."

I called the grants manager and asked some questions. Yes, they were doing things differently than before. Yes, they were looking for projects that would make a significant impact. And yes, there are many big races taking place across the country. As I wondered about our odds, Dick Hattershire said, "if you don't ask, the answer is always no."

So, Jo Lovelace Hill, Mario and I talked and came up with a proposal and submitted it. I thought, "let's see what happens."

Fast forward two weeks. At the end of the day before the holiday weekend, I glanced at my emails. The first thing I saw was CONGRATULATIONS! Intrigued, I opened it thinking that maybe I had won a trip to Vegas. When I saw who it was from, I yelled YES!! and may have startled our neighbors!

Jo and I will be contacting you for help. On National Voter Registration Day, we'll staff at least 15 voter registration tables throughout Greene and Montgomery Counties with the goal of engaging people of color and underserved populations. We will also conduct a candidates' forum. Let us know if you'd like to help!

## **Keynote Speaker: Tom Archdeacon**

DID YOU KNOW that a mother's letter to her son helped push the last-minute final vote for ratification of the 19th Amendment into the 'win' column? On August 18, 1920, the all-male Tennessee legislature was divided between those who didn't support the vote (wearing red roses in their lapels to show their intentions) and those who did support the vote (wearing yellow roses in their lapels). The Tennessee Senate had already approved the amendment, but a tie in the House meant defeat. They could only win if ONE of the House opponents changed his mind. The roll call had landed on Harry T. Burn; at 24 the youngest state lawmaker. He had voted twice to table the amendment. On his lapel was a red rose. But beneath the rose, in the pocket of his suit jacket, was a letter delivered that morning from his mother, Febb Burn. Between updates on the farm and the family, she had slipped in three references to the vote.

"Hurrah and vote for suffrage," she told her son, "and don't keep them in doubt. Don't forget to be a good boy and help Mrs. 'Thomas Catt' with her 'rats.' Is she the one that put rat in ratification? Ha!

No more from Mama this time. With lots of love."

And her son knew what he had to do. "Aye," said Harry Burn, and he pulled off his red rose.

Tennessee became the "Perfect 36th" and women were legally able to vote!

## **HB294 Proposes Restrictive Changes** to Ohio Voting Laws

In early May, Representative Bill Seitz (R-Cincinnati) introduced HB 294 that would put changes and restrictions on Ohio laws related to early voting, voter ID for absentee ballot requests, and ballot drop boxes. While Republicans say Ohio's voting laws are already good and this will improve them, Democrats say it will lead to voter suppression.

In terms of early voting, the bill would eliminate inperson voting the day before the election, although those hours could be reallocated to other days. Historically, the

Monday before election day has been a popular day for early voting, although some election officials are in favor of this change. The bill would also require two forms of ID to request an absentee ballot in an online request process. The current requirement is for one form of approved voter ID. Online requests would not require voters to print out

the application and mail it in, which some have said would be better than the current system. The bill would disqualify ballots not returned in ID envelopes and would ban state-paid return postage for absentee ballots (unless lawmakers vote to approve that). It would also require that requests for absentee ballots must be received by 10 days before the election. The current deadline is three

days. The proposed legislation would also limit counties to three ballot drop boxes on Board of Elections property for 10 days prior to the election, not for the full four-week early voting period. Currently, Montgomery County has an exterior and interior drop box, operational 365 days at all hours so that voters can drop off absentee ballot requests and voter registration forms. It would create automated registration through the Bureau of Motor Vehicles rather than automatically registering all adults to vote, which Democrats have wanted.

In an interview for "The State of Ohio," Seitz stated that he's no fan of Ohio's four weeks of early absentee voting, and has said that's the one vote in his 21-year legislative career he wishes he could take back. He also indicated that some of his Senate colleagues would like to dramatically cut back or even eliminate the no-excuse absentee voting that's been in

place since 2005.

The bill has had two hearings in the House, both of which have been highly contentious. Hearings are planned to resume soon.

- Reducing access to secure, efficient drop boxes
- Requiring excessive and complicated identification rules that create unnecessary work for elections officials and poll workers, while likely denying eligible voters
- Making it harder for active-duty military voters overseas to vote (this affects military personnel from Wright-Patterson AFB here in Greene County)
- Undermining Ohioans' freedom to vote in the manner of their choice

## **Redistricting Map-Drawing Can Start Mid-August**

**Background:** Thanks to the passage of redistricting reform legislation in 2015 and 2018, Ohio's constitution requires, for the first time, an independent commission to finish redrawing legislative districts by September 1, 2021. It sets a September 30 deadline for the state's General Assembly to complete a new map of congressional districts in time for the 2022 election.

**The Problem:** Legislators and community groups like LWV were concerned that the Census Bureau would not be able to produce data needed to draw new districts lines in time for Ohio to meet the new constitutional deadlines when the Commerce Department announced a delay in producing the Census data due to the pandemic. The State of Ohio sued for the release of the relevant 2020 data, and as part of a settlement announced mid-May of this year, the Census Bureau promised to release the redistricting data no later than **August 16**.

What's Next: LWVGDA is coordinating a community mapmaking initiative for Montgomery and Greene Counties. The objective is to define and describe the communities of interest that should be the building blocks for fair and effective districts. Our mapmaking team meets with small groups of community members to talk about their communities, then uses a software program called DistrictR to create community maps that become part of a statewide map. These group and individual maps are important as they serve as community 'testimony' in the legislative process. YOU can get involved by:

- Attending an upcoming informational seminar in our region
- Hosting a map-drawing 'party' led by one of LWVGDA trained map facilitators
- Using the free 'DistrictR' web tool to draw your own map (find the link on FairDistrictsOhio.org/community-mapping)
- Joining LWVGDA Redistricting/Fair Elections Committee, led by Kim Senft-Paras, and get involved!
