Reviving civility in politics is the first item on the League of Women Voters of the United States' legislative watch list. Civility, according to Merriam-Webster, is "civilized conduct, especially courtesy, politeness, a polite act or expression." It comes from the Latin root civilis, which means "relating to public life, befitting a citizen."

We're not seeing much of that right now. Using degrading language and namecalling have become the norm. We can no longer have a spirited discussion about ideas without the conversation breaking down into a yelling match. I have friends who, by all accounts share my views on social issues, that regularly call others stupid or ignorant because someone disagreed with their point of view. Families are divided and decades-long friendships have ended because of political differences.

Let's face it, there's a lot going on in the world that's just out and out wrong; but being civil doesn't mean that we sit back and do nothing. One of my favorite quotes from Ruth Bader Ginsburg is:

"Fight for the things you care about but do it in a way that will lead others to join you."

It reminds me that I need to practice active listening, think before I speak and to be aware that my actions may cause a reaction, sometimes good, sometimes not.

As we move into 2022, I'm hopeful that we'll be able to rediscover civility by exploring what we have in common and work together to find the common good.

Keynote Speaker, Dean Verna Williams

Verna Williams is Dean of Law at the University of Cincinnati College of Law. Dean Williams joined the College of Law in 2001 after practicing many years in the areas of civil and women's rights. Prior to her appointment as Dean, she taught in the areas of family law, gender discrimination, and constitutional law, and co-directed the College's Judge Nathaniel Jones Center for Race, Gender, and Social Justice.

Before joining the College of Law, Dean Williams was Vice President and Director of Educational Opportunities at the National Women's Law Center, where she focused on issues of gender equity in education. During her time at the Center, Dean Williams was lead counsel and successfully argued before the United States Supreme Court *Davis v. Monroe County Board of Education*, which established that educational institutions have a duty to respond to and address complaints of student-to-student sexual harassment.

Dean Williams also clerked for the Hon. David S. Nelson, U.S. District Judge for Massachusetts. After the clerkship, she practiced law at the Washington, D.C. office of Sidley & Austin and at the U.S. Department of Justice.

Dean Williams' research examines the intersection of race, gender, and class in law and policy. She has presented papers at such venues as the Latina and Latino Critical Race Theory Conference and meetings of the Association of Law, Culture and the Humanities. She has also served as a consultant for the Ford Foundation; in that capacity, she chaired the convening of a national conference at UC entitled *Women Coming Together:* Claiming the Law for Social Change. Dean Williams received the Goldman Prize for Excellence in Teaching in 2004 and 2011. Dean Williams is a *cum laude* graduate of Harvard Law School and Georgetown University.

Dayton League Formulates Diversity, Equity and Inclusion Policy

In August 2020, the Dayton League formed a committee to address Diversity, Equity and Inclusion in our organization. This follows the lead of our National and State organizations.

At the last Board meeting, Dona Fletcher, Chair of the Committee, led the group in a presentation of what DEI means and how we can begin implementing it in our League work. This was the culmination of work by the Committee, the Board and Committee Chairs over the past year. Most notable was a three-day workshop facilitated by LWVUS in July.

While we have temporarily adopted the LWV US DEI policy, our goal is to develop a policy for the Dayton League that reflects our community. In January, the Board will begin brainstorming different policy verbiage. That work will be brought into the committees for discussion. The last phase will include larger conversations with the membership before settling on a DEI policy that reflects all aspects of our community and the goals of the League of Women Voters in general.

We are not waiting to implement the values of DEI, however. All monthly reports from Board members will now include a section to document how DEI is being implemented in their activities for the League.

These are the definitions we are working with that come from LWVUS.

Diversity includes all of the similarities and differences among people and also refers to population groups that have been historically underrepresented in socially, politically, or economically powerful institutions and organizations. A person is not diverse—they are a unique, individual unit. They may bring diversity to your team, but they, in themselves, are not diverse.

Equity takes into account that people have different access to resources because of a system of oppression and privilege. Equity prioritizes efforts to ensure the most underserved and marginalized among us have as much of an opportunity to succeed as the most well-served and advantaged.

Inclusion is an ongoing process, not a static state of being. It refers to the degree to which diverse individuals are able to participate fully in the decision-making processes within an organization or group.

We will be updating the membership on a regular basis on this work and look forward to group conversations as we formulate our unique Dayton League policy.



VOLUNTEER VOICES



"If you want peace, work for justice." Pope Paul VI

Dayton, Ohio is once again on the map for a "first" in the world of peace, thanks in part to LWV member and peace activist Catherine Queener. You're probably aware of the International Peace Museum, the only brick-and-mortar building in the United States dedicated to peace, founded in 2004. And the Dayton Literary Peace Prize has put us on the map internationally since 2006 as the only U.S. literary prize dedicated to peace. Now, Catherine has coordinated the effort to create the **Miami Valley Peace Heroes Trail** (MVPHT). The first-of-its-kind site, located on the grounds of Miami Valley Unitarian Universalist Fellowship (MVUUF), 8690 Yankee Street in Dayton, is a permanent exhibit of metal signs that include a photograph and brief description of each peace hero recognized, as well as a sign explaining the trail. Catherine credits Reverend Kellie Kelly of MVUUF and Jerry Leggett, former Director of Youth Religious Education at MVUUF and Founder of the 21st Century Peace Literacy Foundation, for instigating and leading the project. Jerry has continued advising the team after moving out of the area.

Catherine describes peace heroes as "often everyday people who accept risk and succeed in making the world a less violent and more just place." She says, "Peace heroes strive to: recognize interconnections, promote justice, reject vengeance, and foster friendship and reconciliation."

The mission of the Peace Heroes Trail is:

- ◆ To lift up peace heroes locally, nationally and worldwide who inspire a new generation of peacebuilding young and old alike;
- To create an onsite (Peace Hero Trail) and online peace literacy exhibit available to the greater Miami Valley community and beyond;
- To provide intergenerational mentoring between experienced and new peace builders;
- ◆ To raise funds for local and national "Peace Literacy for All" endeavors.

After Covid cancelled the originally planned event which would have brought many people together for a walk at Courthouse Square in May 2020, the idea for a permanent outdoor exhibit was born. The first 19 signs were installed in December 2020, and on October 31, 2021 the MVPHT officially opened with an additional 20 signs, a celebration, and the opportunity to meet present-day peace heroes such as Amaha Sellassie, one of the founders of Gem City Market and Co-Executive Director of CO-OP Dayton. Other Peace Heroes honored on the trail include suffragists Ida B. Wells and Lucy Stone, Greta Thunberg, Abraham Lincoln, historian and museum director Dr. James Fleming, and the Dayton Mediation Center. Catherine explains, "Peace Heroes are nominated by MVPHT captains, who then commit to raising or donating funds and involve everyone they know in learning about their hero. I think everyone who captains a team experiences joy, positivity, and power in talking about their peace hero. This is something people hunger to share with each other."

The MVPHT is a free resource, standing ready to welcome individuals, school groups, families, and community groups. All are welcome to visit, to be inspired, and to perhaps find within ourselves a willingness to, in the words of Catherine when describing her hope for the project, "imbed peace heroes and peace literacy into our thought patterns, a practice that affects the way we talk to each other, including our children and grandchildren, and affects future behavior." In other words, this exhibit could change the world; something for which Dayton, Ohio is known.
