The past few months have been difficult. The overturning of Roe v. Wade opened the very real possibility that we may lose even more rights. We've witnessed the aftermath and the senselessness of multiple mass shootings. Every facet of the electoral process may be upended by the Supreme Court by giving state legislatures the ability to set new rules for elections with few checks and balances. Many of us are feeling angry, scared and maybe even a little helpless.

So, what can we do? Should we attend rallies? Yes. Do we need to write and call our elected officials? Of course. But what's going to make the real difference is that everyone needs to encourage their family, friends, and neighbors to get out there and vote. Offer to drive a neighbor to your polling place, bug your kids, offer to take a friend to lunch after you vote, make a plan.

To help get the word out, we've ordered "Register to Vote!" yard signs from Fair Districts that will be available at the office beginning July 27. I'd love to get as many as we can throughout Greene and Montgomery Counties. If you're interested, come down between 9:00 and 5:00 to pick one up for your front yard. 


Ms. Brown will share some little-known facts about Harriet Tubman and share stories that explain why selflove is the first step to changing the world.

### Your District May Have Changed!

With all the confusion over redistricting, who is running, and what polling places will be open, it is imperative that you check your voter information before going to vote.

Please take the time to CHECK YOUR VOTER INFORMATION.

**Montgomery County voters** follow this link Greene County voters follow this link

You will be prompted to enter your first and last name. Your name and birth date will appear on the left hand side. Click on Voter Details. There is a lot of information, but if you scroll down to Your Voting Districts, you will see all the ballot areas you are able to vote on. Up at the top of that page you can see a sample ballot. For the primary, you need to choose either D (Democrat) or R (Republican).

Also on the ballot are State Central Committee candidates. These elected persons run the Republican and Democratic parties in Ohio. Among other things, they allocate funds and vote on candidate endorsements.

For this primary, there is a write-in candidate for the Ohio House 39th District. Follow the directions on the ballot to vote for this candidate. If you do not remember the name of the candidate, you may request a paper with the candidate name on it for your use at your polling location.

# Program Focus: Ohioans to Vote on Bail Reform Amendment

On November 8, voters will decide whether a proposed amendment to the Ohio Constitution to change the rules for cash bail is, as proponents claim, a better way to maintain public safety, or as opponents claim, a shift in power from the Courts to the

General Assembly that won't impact public safety at all.

A decision by the Ohio Supreme Court in January upholding a reduction in bail didn't sit well with Ohio's State legislature; it seemed to them weak on public safety. They immediately proposed legislation to put an amendment to the Constitution on the ballot this fall. The legislation passed along party lines. If the Amendment passes, it will shift control of bail rules from the Rules of Criminal Procedure, defined by the

Supreme Court, to any laws that the General Assembly may pass. It also changes the wording to include the phrase "public safety" when determining the amount of bail.

The Rules of Criminal Procedure already include public safety, with provisions for electronic monitoring, treatment programs, and other restrictions.

Regardless of the outcome of this amendment, other work on bail reform will continue, with bi-partisan bail reform measures currently in committee in the State legislature.

Voters will be either voting Yes to shift control of bail rules from the Rules of Criminal Procedure, defined by the Supreme Court, to any laws that the General Assembly may pass, or voting No to keep the current Constitutional language and the current balance of power between the judicial and legislative branches of government.



## Introducing Our New Summer Intern, Maria

### League Hosts Tony Hall and Bob Taft

The League hosted "Reaching Across the Aisle: A Conversation with Tony Hall and Bob Taft" on



June 8, 2022, at the Fitz Center for Leadership in Community. Given the volatile atmosphere in politics today, we wanted to hear from politicians who had successfully worked with others with different points of view to drive change.

**Ashley Bethard,** *Dayton Daily News* Editor and Chief Content Officer, moderated the event.

Tony Hall, a Democrat, who has been nominated three times for the Nobel Peace Prize, is a leading advocate for hunger relief programs and improving human rights conditions in the world. He served the Third District of Ohio in the U.S. House of Representatives for almost twenty-four years. While serving in the House of Representatives as a Democrat, Mr. Hall was invited by President George W. Bush to serve as the United States Ambassador to the United Nations Agencies for Food and Agriculture. In 2015, Mr. Hall founded the Hall Hunger Initiative to collaborate with community partners to create a just and equitable food system in the Dayton region.

Bob Taft, a Republican, began his career in public service as a Peace Corps volunteer (an experience he shares with Tony Hall), working as a schoolteacher in Tanzania, East Africa after graduating from college. He served as an elected official in Ohio for thirty years as a member of the state legislature, a county commissioner, Ohio Secretary of State and Governor of Ohio (1999-2007).

Each agreed that building relationships is key to driving change. Hall mentioned that years ago, legislators lived in Washington, socialized with each other, had dinner together, and their kids played together. Now, elected officials have little time to build that trust with one another which leads to friendships and the capacity to listen. Moreover, today's campaigns focus on attacks, meaning it's more difficult later to find ways to work together.

Taft said that when he was governor, he reached out to the communities who in large did not vote for him, to determine their needs. He then created legislation, working on both sides of the aisle, to address those needs.

Each is worried about the state of our democracy. They are concerned about the vast

amounts of money coming from PACs, the way that primaries are run, and that 80% of the districts are not competitive, meaning that whoever wins the primary is the person who will win the general election.

Each agreed that the only way that we are going to be able to reach a level of bipartisanship is to stop the personal attacks and to get back to the real reason people should want to become elected officials; to make a difference.

We recently received a note from a community member who saw the article about this event in the *Dayton Daily News*: ". . . (we) need more of this type of civil discourse - thank you again," and also a request to duplicate the event in Warren County!
